## I. SUPERINTENDENT'S CONTRACT

Motion carried.

A motion was made by Awbrey that the Board add to the agenda: Authorizing Board President to seek legal counsel to negotiate with Superintendent during contract proceedings.

After some discussion, Awbrey withdrew his motion.

There being no further business, it was moved by Hefner, seconded by Meyer, and carried that the meeting adjourn.
