II. RECAP OF BUDGET PROCESS FOR 2006-2007

Motion (Guidry, Hefner) that the Board hire a full-time assistant principal to be shared with Truman Montessori and Prairie Elementary Schools equally.

A substitute motion was made by Wilson and seconded by Hefner that the Board hire a full-time assistant principal at Truman Montessori, and a part-time assistant principal at Prairie Elementary.

After some discussion, Wilson withdrew her substitute motion.

The Chair called for a voice vote on the original motion. Motion carried. Thibodaux requested that he be recorded as voting NO.

Motion (Thibodaux, Hardy) that the Board cap K-3 classes at 19.

After some discussion, Hardy withdrew his second and the motion died for lack of a second.

A motion was made by Thibodaux that the Board cap K-1 classes at 19 and add a grade level each year. Motion died for lack of a second.

Motion (Hefner, Hardy) that the Board have staff make the appropriate changes to the budget as discussed today, and that a Public Hearing on the budget be held at 4:00 p.m., and a Special Board Meeting to adopt the budget be held at 4:30 p.m. on Wednesday, August 23, 2006. Motion carried.

The Chair turned the gavel over to the Vice-President and exited the meeting.

There being no further business, it was moved by Hardy, seconded by Hefner and carried that the meeting adjourn.
